

## **Submitting a Rental Application**

When submitting a rental application to SP Investment Properties, LLC, you will need the following along with the application itself:

- \$50 Non-Refundable Application fee **per** adult in certified funds payable to: **SP Investment Properties, LLC.**
- Identification.
- Pay stubs for the past month or 2 years of Tax Returns if you are selfemployed.
- Each Applicant needs an email address.
- Proof of other income.
- Relationship to other applicant(s) must be noted on the application. Examples: Significant other, roommate, spouse, family.
- Picture of pet **MUST** be included.
- \$25 pet fee per month per pet.
- A security deposit, in certified funds, is due upon approval of rental application. Security deposit will hold a unit for two weeks.
